I. GENERAL COURTS MARTIAL.—All persons subject to military law stationed within the territorial limits of the Military District of Washington, and not under the command of any other officer authorized to appoint general courts martial, are under the jurisdiction of the Commanding General, Military District of Washington, in all matters pertaining to the administration of military justice, regardless of whether the installation or activity at which such persons are stationed, or with which they are on duty, is under the command of the Commanding General, Military District of Washington.

II. SAN ANTONIO GENERAL DEPOT, U. S. ARMY, SAN ANTONIO, TEXAS.—Effective as of 1 July 1949, the Ordinance Section of San Antonio General Depot, U. S. Army, San Antonio, Texas, was discontinued.

III. SECTION 55C, NATIONAL DEFENSE ACT, UNIT.—Effective as of 1 July 1949, the section 55c, National Defense Act, training unit at Texarkana High School, Texarkana, Texas, was withdrawn.

IV. SIGNAL CORPS CENTER, FORT MONMOUTH, NEW JERSEY.—Effective as of 1 August 1949, the Signal Corps Center was established at Fort Monmouth, New Jersey, as a class II activity under the jurisdiction of the Chief Signal Officer, and will consist of the following activities:

- a. The Signal Corps Engineering Laboratories.
- b. The Signal Corps Board.
- c. The Signal School.
- d. The Signal Corps Publications Agency.
- e. The Signal Patent Agency.
- f. The Signal Corps Intelligence Unit.
- g. The Pigeon Breeding and Training Center.
- h. The Army portion of the Armed Services Electro-Standards Agency.
- i. All Signal Corps troop units stationed at Fort Monmouth, New Jersey.
