**I..BEAVER AMMUNITION STORAGE POINT, OREGON.**—Effective 19 July 1950, the Beaver Ammunition Storage Point, Oregon, is established as a class II subinstallation of the Seattle Port of Embarkation, Washington, a class II installation under the jurisdiction of the Chief of Transportation.

**II..ILLINOIS ORDNANCE PLANT, CARBONDALE, ILLINOIS.**—Effective 12 June 1950, the Illinois Ordnance Plant, Carbondale, Illinois, a class II installation under the jurisdiction of the Chief of Ordnance is discontinued.
