II..CAMP BRECKINRIDGE, MORGANFIELD, KENTUCKY.—Effective 24 July 1950 Camp Breckinridge, Morganfield, Kentucky, a class I installation under the jurisdiction of the Commanding General, Second Army, is placed in an active status.
