I..SOUTHWESTERN SIGNAL TRAINING GROUP.—Effective 1 November 1951, the Southwestern Signal Training Group is established as a class II activity, under the jurisdiction of the Chief Signal Officer, at Camp San Luis Obispo, California, a class I installation under the jurisdiction of the Commanding General, Sixth Army.

II..BARRANCAS NATIONAL CEMETERY, FLORIDA.—The Barrancas National Cemetery, Escambia County, Florida, named in WD General Orders 7, 1936, and described in Military Reservations, Florida, was expanded by transfer of land from the Department of the Navy on 17 November 1950 pursuant to section 2, Act 10 August 1950 (64 Stat. 434; 24 U. S. C. Supp. IV, 281g). This reservation now comprises the following described land:

All that tract or parcel of land lying in sec. 24, Township 3 South, Range 30 West, Tallahassee meridian, and lying entirely within the United States Naval Reservation, Pensacola, Escambia County, Florida, containing 29.91 acres, more or less, and described as follows: From Fort Barrancas East Water Tank, the position of which has been established by the United States Coast and Geodetic Survey; thence N. 83°30'15" E., 1,213.7 feet to the southwest corner of tract, the point of beginning, from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 7 1951" lies S. 52°05' W., 6.0 feet; thence N. 07°18' E., 109.4 feet to a point on the westerly boundary from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 8 1951" lies N. 82°47' W., 4.2 feet; thence N. 07°13' E., 612.1 feet to a point on the westerly boundary from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 1 1951" lies N. 82°44' W., 4.2 feet; thence N. 07°18' E., 899.8 feet to the northwest corner from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 2 1951" lies N. 82°42' W., 4.2 feet; thence S. 82°42' E., 864.9 feet to a point on the northeasterly boundary from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 3 1951" lies S. 82°42' E., 5.0 feet; thence S. 46°28' E., 179.4 feet to a point on the northeasterly boundary from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 4 1951" lies S. 46°28' E., 5.3 feet; thence S. 23°06' W., 1,120.7 feet to a point on the easterly boundary from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 5 1951" lies S. 76°54' E., 5.0 feet; thence continue S. 23°06' W., 450.2 feet to the southeast corner from which a hole in a standard bronze National Cemetery disk set in a concrete post and stamped "WC 6 1951" lies S. 36°34' E., 5.8 feet; thence N. 83°05' W., 580.7 feet to the southwest corner, the point of beginning.

Bearings and distances are based upon an actual survey and are referred to the Lambert Projection for the State of Florida, North Zone.
