I..GENERAL COURTS-MARTIAL.—The Commanding Officer, Fort Huachuca, Arizona, is designated by the Secretary of the Army pursuant to the Uniform Code of Military Justice, Article 22 (a) (6), to convene general courts-martial, *effective 5 April 1954.*

2. The continuance of finance services now furnished to class II installations and activities by the Finance Office, U. S. Army, Fort Monroe, Virginia shall be a responsibility of the Commanding General, Second Army, until other arrangements are authorized by the Department of the Army.

2. The continuance of finance services now furnished to class II installations and activities by the Finance Office, U. S. Army, Omaha, Nebraska, shall be a responsibility of the Commanding General, Fifth Army, until other arrangements are authorized by the Department of the Army.
