**I..ARMORED REPLACEMENT TRAINING CENTER, FORT KNOX, KENTUCKY.**—Effective 15 March 1955, an Armored Replacement Training Center is established as a class I activity at Fort Knox, Kentucky, a class I installation under the jurisdiction of the Commanding General, Second Army.

**II..THE ARMY GENERAL SCHOOL, FORT RILEY, KANSAS.**—Effective 1 May 1955, the Army General School, a class I activity under the jurisdiction of the Commanding General, Fifth Army, is discontinued. Its component elements are reassigned as follows:

a. The Intelligence Division of the Department of Resident Instruction, The Military Intelligence Branch of the Extension Course Division, The School Troops Detachment, and other supporting elements to Commanding General, Army Intelligence Center, Fort Holabird, Maryland.

b. The Department of Extension Courses less the Military Intelligence Branch, The National Guard State OCS, and The Physical Training Department to the Commanding General, The Infantry Center, Fort Benning, Georgia. The date of reassignment and movement of these elements will be at the discretion of the Commanding General, CONARC but not later than 1 May 1955.

c. The Psychological Warfare Extension courses to the Commandant, Psychological Warfare School, Fort Bragg, North Carolina.

d. The Aggressor Cadre and Sonic Effects Platoon to the Commandant, Command and General Staff College, Fort Leavenworth, Kansas. These elements will remain stationed at Fort Riley, Kansas.

**III..THE COUNTER INTELLIGENCE CORPS SCHOOL, FORT HOLABIRD, MARYLAND.**—Effective 1 May 1955, the Counter Intelligence Corps School, a class II activity under the jurisdiction of the Commanding General, Army Intelligence Center, Fort Holabird, Maryland, is redesignated the Army Intelligence School, a class II activity under the same jurisdiction.

**IV..OFFICE OF THE ARMY INFORMATION DIGEST.**—Effective 1 April 1955, the Office of the Army Information Digest, a class II activity under the jurisdiction of the Chief of Information and Education, is discontinued at Fort Slocum, New York, a class I installation under the jurisdiction of the Commanding General, First Army, and is concurrently reestablished at Cameron Station, Alexandria, Virginia, a class I installation under the jurisdiction of the Commanding General, Military District of Washington.

**V. CAMP KILMER, NEW JERSEY.**—Effective 30 June 1955, Camp Kilmer, New Jersey, a class I installation under the jurisdiction of the Commanding General, First Army, is placed in an inactive status.

**VI. ROTC UNIT, DARTMOUTH COLLEGE, HANOVER, NEW HAMPSHIRE.**—Effective the beginning of the 1955-56 academic year, the Ordnance Corps ROTC unit at Dartmouth College, Hanover, New Hampshire, is converted to a General Military Science ROTC unit.

**VII. ROTC UNIT, SEATTLE UNIVERSITY, SEATTLE, WASHINGTON.**—Effective the beginning of the 1955-56 academic year, the Ordnance Corps ROTC unit at Seattle University, Seattle, Washington, is converted to a General Military Science ROTC unit.
