**I.. ANTI-AIRCRAFT AND GUIDED MISSILES BRANCH, THE ARTILLERY SCHOOL, FORT BLISS, TEXAS.** Effective 13 April 1955, the Antiaircraft and Guided Missiles Branch, The Artillery School, Fort Bliss, Texas, is redesignated The Antiaircraft Artillery and Guided Missile School. The redesignation of this school is not to be construed as altering current relationships with other schools or military agencies.

**II.. ARTILLERY SCHOOL, FORT SILL, OKLAHOMA.** Effective 13 April 1955, the Artillery School, Fort Sill, Oklahoma, is redesignated The Artillery and Guided Missile School.

**III.. ARTILLERY CENTER, FORT SILL, OKLAHOMA.** Effective 13 April 1955, the Artillery Center, Fort Sill, Oklahoma, is redesignated the Artillery and Guided Missile Center.

**IV.. ARMORED CENTER, FORT KNOX, KENTUCKY.** So much of section III, DA General Orders 58, 1954, as reads "OCAFF Board Number 2" is amended to read "CONARC Board Number 2."

**V.. ANTI-AIRCRAFT AND GUIDED MISSILE CENTER, FORT BLISS, TEXAS.** So much of section IV, DA General Orders 58, 1954, as reads "Army Field Forces Board Number 4" is amended to read "CONARC Board Number 4."

**VI.. INFANTRY CENTER, FORT BENNING, GEORGIA.** 1. So much of section V, DA General Orders 58, 1954, as reads "OCAFF Board Number 3" is amended to read "CONARC Board Number 3."

2. So much of section V, DA General Orders 58, 1954, as reads "47th Infantry Division" is amended to read "3d Infantry Division."

**VII.. ARTILLERY CENTER, FORT SILL, OKLAHOMA.** So much of section VI, DA General Orders 58, 1954, as reads "Army Field Forces Board Number 1" is amended to read "CONARC Board Number 1."

**IX. FINANCE OFFICE, U. S. ARMY, MEMPHIS, TENNESSEE.** *Effective 2 April 1955*, the Finance Office, U. S. Army, Memphis, Tennessee, a class II activity under the Chief of Finance is discontinued, and its functions assigned to The Quartermaster General.

**X. FINANCE OFFICE, U. S. ARMY, OGDEN, UTAH.** 1. *Effective 15 April 1955*, the Finance Office, U. S. Army, Ogden, Utah, a class II activity under the Chief of Finance is discontinued, and its functions assigned to The Quartermaster General.

2. The continuance of finance services now furnished to class II installations and activities by the Finance Office, U. S. Army, Ogden, Utah, shall be the responsibility of The Quartermaster General, until other arrangements are authorized by the Department of the Army.

**XI. TRANSPORTATION STANDARDIZATION AGENCY, WASHINGTON, D. C.** *Effective 1 April 1955*, the Transportation Standardization Agency is established at Washington, D. C., as a class II activity under the jurisdiction of the Chief of Transportation. This Agency will effect nonmateriel standardization among the United States, United Kingdom, and Canadian Armies.
