**I..GENERAL COURTS-MARTIAL.** The Commanding Officer, Southern European Task Force, is designated by the Secretary of the Army, pursuant to the Union Code of Military Justice, Article 22a (6), MOM, 1951, to convene general courts-martial *effective 25 October 1955*.

**II..DEPARTMENT OF DEFENSE MILITARY PERSONNEL RECORDS CENTER, MISSOURI.** *Effective 17 October 1955*, the Department of Defense Military Personnel Records Center, Missouri, is established as a class III installation, under the jurisdiction of The Adjutant General, and placed in an active status.

**III..ST. LOUIS ADJUTANT GENERAL PUBLICATIONS CENTER MISSOURI.** *Effective 17 October 1955*, the St. Louis Adjutant General Publications Center, Missouri, a class III installation under the jurisdiction of The Adjutant General, is redesignated as a class II activity at the Department of Defense Military Personnel Records Center.

**IV..MEDICAL FIELD SERVICE SCHOOL, FORT SAM HOUSTON, TEXAS.** *Effective 1 November 1955*, the Medical Field Service School located at Brooke Army Medical Center, a class II activity at Fort Sam Houston, Texas, is redesignated the Army Medical Service School.

**VII..HOUSTON INDEPENDENT SCHOOL DISTRICT, HOUSTON, TEXAS.** *Effective 26 September 1955*, a multiple school, military training unit under the
