I. GENERAL COURTS-MARTIAL. The Commanding Officer, The Engineer Center and Fort Belvoir, Fort Belvoir, Virginia, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22a (6), MCM, 1951, to convene general courts-martial, *effective 1 January 1958.*

II. GENERAL COURTS-MARTIAL. The Commanding Officer, 1st Infantry Division and Fort Riley, Fort Riley, Kansas, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22a (6), MCM, 1951, to convene general courts-martial, *effective 1 February 1958.*

V. ROTC UNIT, HARVARD UNIVERSITY, CAMBRIDGE, MASSACHUSETTS. *Effective the beginning of the 1956-57 academic year,* the Field Artillery unit at Harvard University, Cambridge, Massachusetts, is converted to a General Military Science ROTC Unit.
