I. GENERAL COURTS-MARTIAL. The Commanding Officer, the United States Army Training Center, Field Artillery, Camp Chaffee, Arkansas, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), MCM 1951, to convene general courts-martial, *effective 16 March 1956.*

II. GENERAL COURTS-MARTIAL. The Commanding Officer, the United States Army Training Center, Infantry, Fort Dix, New Jersey, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), MCM 1951, to convene general courts-martial, *effective 16 March 1956.*

III. GENERAL COURTS-MARTIAL. IV. SIGNAL CORPS PHOTOGRAPHIC LIBRARY AND LABORATORY, WASHINGTON, D. C. *Effective 1 April 1956,* the Signal Corps Photographic Library and Laboratory, Washington, D. C., a class II activity under the jurisdiction of the Chief Signal Officer, is redesignated the Army Photographic Agency.

V. THE SIGNAL CORPS PLANT ENGINEERING AGENCY, WASHINGTON, D. C. *Effective 1 April 1956,* the Signals Corps Plant Engineering Agency, Washington, D. C., a class II activity under the jurisdiction of the Chief Signal Officer, is redesignated the Army Signal Communications Engineering Agency.

VI. INSTALLATIONS IN HAWAII. *Effective 25 March 1956,* the following installations in Hawaii, under the jurisdiction of the Commanding General, United States Army, Pacific, are announced as permanent Department of the Army installations:

VII. KING'S BAY ARMY TERMINAL, GEORGIA. *Effective 1 April 1956,* the King's Bay Army Terminal, St. Marys, Georgia, is established and placed in inactive status as a class II installation under the jurisdiction of the Chief of Transportation, and is assigned to the Headquarters, Atlantic Transportation Terminal Command.

VIII. THOMAS JEFFERSON HIGH SCHOOL, DALLAS TEXAS. *Effective 8 March 1956,* a military training unit under the provisions of section 55c, National Defense Act, as amended, is established at Thomas Jefferson High School, Dallas, Texas.

IX. SIGNAL CORPS CENTER, FORT MONMOUTH, NEW JERSEY. *Effective 1 March 1956,* section IV, General Orders 35, 1949, which established the Signal Corps Center at Fort Monmouth, New Jersey, is rescinded. Fort Monmouth remains a class III installation under the jurisdiction of the Chief Signal Officer.

X. REDESIGNATION OF CLASS III INSTALLATIONS AS CLASS II INSTALLATIONS. Section III, General Orders 4, 1956, is amended to read as follows:

1. *Effective 1 April 1956,* the following class III installations are redesignated class II installations:
