Rhineland.** WD General Orders 118, 1945; as amended by section IV, DA General Orders 29, 1948; paragraph 11, section I, DA General Orders 72, 1948; paragraph 11, section II, DA General Orders 6, 1950; paragraph 14, section I, DA General Orders 37, 1950; paragraph 17, section III, DA General Orders 32, 1953; section II, DA General Orders 50, 1953; paragraph 2, section VI, DA General Orders 87, 1953; paragraph 3, section VIII, DA General Orders 9, 1954; paragraph 3, section I, DA General Orders 25, 1954; paragraph 5, section V, DA General Orders 57, 1954; paragraph 1, section VII, DA General Orders 74, 1954; paragraph 3, section IV, DA General Orders 9, 1955; and paragraph 2, section I, DA General Orders 28, 1956, pertaining to the Rhineland campaign is further amended as follows:
