I.. NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE. *Effective 3 April 1961*, Brigadier General John A Heintges, USA, Director, Organization and Training, Office, Deputy Chief of Staff for Military Operations, is announced as a member of the National Board for the Promotion of Rifle Practice, and Chairman of the Executive Committee, representing Office, Deputy Chief of Staff for Military Operations, vice Major General George T. Duncan, reassigned.

II.. CAMP EDWARDS, MASSACHUSETTS. This confirms discontinuance of Camp Edwards, Massachusetts, as a Department of the Army installation, effective 29 September 1955.
