**I. GENERAL COURTS-MARTIAL.** The Commanding Officer, U.S. Army Materiel Command, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial, *effective 1 July 1962.*

**II. ARMY INTELLIGENCE AND SECURITY BRANCH.** *Effective 1 July 1962,* Pursuant to the authority contained in title 10, United States Code, section 3063(a)(13), the Army Intelligence and Security Branch is established as a basic branch of the Army.

**III. U.S. ARMY JUDGE ADVOCATE GENERAL'S SCHOOL, CHARLOTTESVILLE, VIRGINIA.** Section II, DA General Orders 34, 14 June 1962, is amended by deleting the U.S. Army Judge Advocate General's School, Charlottesville, Virginia. The U.S. Army Judge Advocate General's School, Charlottesville, Virginia, will remain a class II activity under the jurisdiction of The Judge Advocate General.

**IV. U.S. ARMY ALASKA COMMUNICATION SYSTEM.** *Effective 1 July 1962,* the U.S. Army Alaska Communication System, a class II activity under command of the Chief Signal Officer with headquarters at Seattle, Washington, is transferred to the U.S. Air Force.

**V. FORT WILLIAMS, MAINE.** *Effective 30 June 1962,* Fort Williams, Maine, a class I installation under the jurisdiction of the Commanding General, First United States Army, is placed in an inactive status.
