I. GENERAL COURTS-MARTIAL. The Commanding Officer, the U.S. Army Quartermaster Center and Fort Lee, Fort Lee, Virginia, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 1 July 1962.*

II. GENERAL COURTS-MARTIAL. The Commanding Officer, the U.S. Army Transportation Center and Fort Eustis, Fort Eustis, Virginia, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 1 July 1962.*

III. UNITED STATES ARMY AEROMEDICAL RESEARCH UNIT. *Effective 1 July 1962,* the United States Army Aeromedical Research Unit (3514), is established as a class II activity under the jurisdiction of The Surgeon General, at the United States Army Aviation Center, Fort Rucker, Alabama.

IV. U.S. ARMY STRATEGIC COMMUNICATIONS COMMAND. *Effective 6 July 1962,* the U.S. Army Strategic Communications Command, a class II activity under the jurisdiction of the Chief Signal Officer, at Washington 25, D.C., was relocated to Arlington Hall Station, Arlington 12, Virginia.

V. CAMP HANFORD, WASHINGTON. *Effective 1 November 1961,* Camp Hanford, Washington, was discontinued as a Department of the Army installation.
