**I. UNITED STATES ARMY, CARIBBEAN.** *Effective 6 June 1963*, the United States Army, Caribbean is redesignated United States Army Forces, Southern Command (USARSOUTHCOM).

**II. GENERAL COURTS-MARTIAL.** The Commanding Officer, Antilles Command, United States Army Southern Command, and United States Army Garrison, Antilles, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial, *effective 6 June 1963*.

**III. U.S. ARMY MATERIEL COMMAND ACTIVITIES.** *Effective 1 December 1962*, the following class II activities, all under the jurisdiction of the Commanding General, U.S. Army Materiel Command, are redesignated as follows:

**IV. ORDNANCE ASSEMBLY PLANT.** *Effective 1 January 1963*, the Ordnance Assembly Plant, a class II activity under jurisdiction of the Commanding General, U.S. Army Materiel Command, at Edgewood Arsenal, Maryland, is discontinued. Functions, personnel, and equipment are integrated with Edgewood Arsenal, Maryland, a class II installation under jurisdiction of the Commanding General, U.S. Army Materiel Command.

**V. WEST COAST MINOR RELAY STATION, LOS ANGELES, CALIFORNIA.** *Effective 1 July 1963*, the West Coast Minor Relay Station, Los Angeles, an activity of the U.S. Army Strategic Communications Command, which is a class II activity under command of the Chief Signal Officer, is discontinued.
