I. U.S. ARMY MATERIEL COMMAND ACTIVITIES. *Effective 1 August 1963*, the following class II activities under the jurisdiction of the Commanding General, U.S. Army Materiel Command, are discontinued. Functions, personnel, funds, records, and equipment are transferred to the Yuma Test Station, a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command.

- a. U.S. Army Chemical Corps Desert Test Activity
- b. U.S. Army Corps of Engineers Desert Test Activity
- c. Ordnance Test Activity
- d. Quartermaster Research and Engineering Airborne Test Activity, U.S. Army
- e. U.S. Army Surveillance Drone Test Detachment

II. U.S. ARMY QUARTERMASTER ACTIVITIES. *Effective 1 August 1963*, the following class II activity, under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is redesignated as follows:

III. QUARTERMASTER FOOD AND CONTAINER INSTITUTE FOR THE ARMED FORCES. *Effective 30 August 1963*, the Quartermaster Food and Container Institute for the Armed Forces, U.S. Army, located at Chicago, Illinois, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is discontinued. Functions of the former Quartermaster Food and Container Institute for the Armed Forces are transferred to Natick Laboratories, Natick, Massachusetts.

IV. OFFICE FOR DEPENDENTS' MEDICAL CARE. *Effective 1 August 1963*, announcement is made of the relocation of the Office for Dependents' Medical Care, a class II activity under the jurisdiction of The Surgeon General, Department of the Army, from Washington, D.C., to Denver, Colorado.

V. U.S. ARMY ELEMENT, U.S. MILITARY LIAISON GROUP, REPUBLIC OF CONGO (SF-1725), Leopoldville, Republic of The Congo. *Effective 14 August 1963*, the U.S. Army Element, U.S. Military Liaison Group, Republic of Congo (SF-1725), is redesignated U.S. Army Element, U.S. Military Mission, Republic of The Congo.
