I.—U.S. ARMY TRAINING CENTER, INFANTRY, FORT BENNING, GA. *Effective 15 September 1965*, the U.S. Army Training Center, Infantry, Fort Benning, Ga., is established as a class I activity under the jurisdiction of the Commanding General, Third U.S. Army.

II.—U.S. ARMY TRAINING CENTER AIR DEFENSE, FORT BLISS, TEX. *Effective 15 October 1965*, the U.S. Army Training Center, Air Defense, Fort Bliss, Tex., is established as a class I activity under the jurisdiction of the Commanding General, Fourth U.S. Army.

III.—U.S. ARMY RECEPTION STATION, FORT BENNING, GA. *Effective 15 September 1965*, the U.S. Army Reception Station, Fort Benning, Ga., is established as a class I activity under the jurisdiction of the Commanding General, Third U.S. Army.

IV.—U.S. ARMY RECEPTION STATION, FORT BLISS, TEX. *Effective 15 October 1965*, the U.S. Army Reception Station, Fort Bliss, Tex., is established as a class I activity under the jurisdiction of the Commanding General, Fourth U.S. Army.

V.—DICKSON GUN PLANT, HOUSTON, TEX. *Effective 2 August 1965*, the Dickson Gun Plant, Tex., is discontinued as a Department of the Army installation.

VI.—UNITS ENTITLED TO USAR AWARD—SECRETARY OF THE ARMY SUPERIOR UNIT CERTIFICATE. General Orders 7, 1965, is amended as follows:
