I. GENERAL COURTS-MARTIAL. The Commanding Officer, 1st Logistical Command, APO San Francisco 96307, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial, *effective 24 January 1966*.

II. DEFENSE CENTRAL INDEX OF INVESTIGATIONS. *Effective 1 February 1966*, the Defense Central Index of Investigations (DCII), is established as a class II activity under the jurisdiction of the Assistant Chief of Staff for Intelligence, Headquarters, Department of the Army, with station at Fort Holabird, Md., 21219, a class 1 installation under the jurisdiction of the Commanding General, First United States Army.

III. WILDWOOD STATION, ALASKA. *Effective 31 December 1965*, Wildwood Station, Alaska, was discontinued as a Department of the Army installation.

IV. SUNFLOWER ARMY AMMUNITION PLANT. So much of section IV, General Orders 41, 1965, as reads "*Effective 29 July 1956*" is amended to read "*Effective 29 July 1965*."
