I. ST. LOUIS ARMY AMMUNITION PLANT. *Effective 18 August 1966*, the St. Louis Army Ammunition Plant at St. Louis, Missouri, a class II inactive installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is placed in an active status.

II. DEFENSE LANGUAGE INSTITUTE SUPPORT COMMAND, FORT BLISS, EL PASO, TEXAS. 1. *Effective 1 August 1966*, the Defense Language Institute Support Command—El Paso (short title “DLISC-EP”) is organized at Fort Bliss, El Paso, Texas, as a class II activity under the command of the Director, Defense Language Institute, a class II activity of the Deputy Chief of Staff for Personnel.

2. The mission of the Defense Language Institute Support Command is to command, control, administer, and provide logistical support to all assigned and attached military and civilian personnel in connection with the Vietnamese language training conducted at Fort Bliss, Texas.
