**1. DISTINGUISHED SERVICE CROSS.** By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action against an enemy is awarded to:

Sergeant *Eldon L. Baker*, , United States Army, distinguished himself by extraordinary heroism on 7 February 1966 in the Republic of Vietnam while serving as a Squad Leader, Headquarters and Headquarters Company, 1st Battalion, 327th Infantry, 1st Brigade, 101st Airborne Division. While engaged in a combat mission to relieve elements of a rifle company which were pinned down by a well-fortified and numerically superior Viet Cong force, Sergeant *Baker* maneuvered his squad to a position approximately one hundred meters from the hostile main battle emplacements. Continuing to evince his indomitable courage, he crawled across a rice paddy under a hail of withering gun fire to reach the enemy position. Although he sustained multiple wounds by enemy gun fire during this action, he turned and rallied his men to continue the advance. Un-

daunted by a throat wound which impaired his speech, he crawled to a second enemy position, signalling his men to follow him. He then pulled himself to his feet and used his pistol to destroy the enemy within the bunker, making it possible for his squad to advance and rout the enemy completely. When medical and evacuation facilities were available, he refused medical attention and evacuation until all of the wounded received medical treatment. Sergeant *Baker's* conspicuous gallantry, extraordinary heroism on the battlefield, and deep concern for his fellow soldiers are in the highest traditions of the United States Army and reflect great credit upon himself and the armed forces of his country. (This award supersedes the award of the Silver Star to Sergeant *Baker* for gallantry in action on 7 February 1966 as announced in General Orders Number 2920, Headquarters, United States Army Vietnam, dated 16 May 1966.)

Staff Sergeant *Oliver J. Fugere, Jr.*, \_\_\_\_\_, (then Sergeant), United States Army, distinguished himself by extraordinary heroism on 5 December 1965 while serving as Squad Leader, Company B, 2d Battalion, 1st Infantry Division during a military operation near Ap Nha Mat, Republic of Vietnam. Staff Sergeant *Fugere's* battalion had been conducting a search and destroy operation in the jungle for seven days and had sustained many casualties when it contacted a well-entrenched Viet Cong force, estimated four battalions in size. As the forward elements of his squad were hit by .50 caliber machine gun and automatic weapons fire, he bravely exposed himself to the deadly gun fire of the Viet Cong to direct his squad's actions against the insurgents. After repelling the initial onslaught and inflicting heavy casualties on the insurgent force, he again exposed himself to the intense gun fire, moved his squad forward to relieve the mortar section, and personally set up a machine gun and delivered a devastating barrage of gun fire into the counterattacking Viet Cong. The effectiveness of his timely support resulted in the repulsion of three insurgent attacks and approximately fifty Viet Cong casualties. Although these hostile forces were driven off, hidden snipers continued to cause friendly casualties and pinned down his squad. Then, with complete disregard for his own safety, he walked up and down a roadway to draw the Viet Cong fire and to detect their positions. While moving on the roadway and using his rifle and grenades, he destroyed the sniper positions and at least two automatic weapons positions. He also marked the position of his unit with smoke to enable accurate airstrikes, and then administered first aid to the wounded and assisted in their evacuation to safety. His indomitable courage, determination, and devotion to duty contributed to the success of the search and destroy operation. Staff Sergeant *Fugere's* extraordinary heroism on the battlefield is in the highest traditions of the United States Army and reflects great credit upon himself and the military service. (This award supersedes the award of the Silver Star to Staff Sergeant *Fugere* for gallantry in action on 5 December 1965 as announced in General Orders Number 1272, Headquarters, United States Army Vietnam, dated 24 February 1966).

Specialist Five *Charles R. Lose*, \_\_\_\_\_, United States Army, distinguished himself by extraordinary heroism on 14 November and 15 November 1965 in Ia Drang Valley, Republic of Vietnam while serving

with Company B, 1st Battalion, 7th Cavalry, 1st Air Cavalry Division. As a Medical Aidman, Specialist *Lose* was serving with the Second Platoon of Company B when the Platoon became pinned down by an intense assault from a battalion size Viet Cong force and then cut off from the remainder of the Company for a period of twenty-six hours. As the enemy's deadly and heavy automatic weapons and small arms fire inflicted several casualties on the Platoon during the initial attack, Specialist *Lose* bravely moved through the hail of gun fire to care for the wounded. Although he was wounded in the foot by grenade fragments during one of his courageous moves to reach a fallen comrade, he continued to administer to the wounded by crawling from man to man dragging his aid kit with him. When his medical supplies became exhausted, he demonstrated rare ingenuity and determination by fashioning bandages from C-ration resources. He collected water from the canteens of the dead for distribution to the wounded. Again and again, he crawled across the open area and exposed himself to the intense hostile fire to give first aid to the wounded, often using his own body as a shield for the protection of his fellow soldiers. On the following day when a relief force reached the beleaguered unit, he refused to be evacuated until all of the wounded were taken to safety. Specialist *Lose's* conspicuous gallantry, his extraordinary heroism on the battlefield, and his deep concern for his fellow soldiers are in the highest traditions of the United States and reflect great credit upon himself and the armed forces of his country. (This award supersedes the award of the Silver Star to Specialist *Lose* for gallantry in action during the period 14 November and 15 November 1965 as announced in General Orders Number 1844, Headquarters, United States Army, Vietnam, dated 25 March 1966).

**IV. SILVER STAR.** By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Master Sergeant *Chris L. Gout*, \_\_\_\_\_, (then Private First Class), United States Army, while serving as a member of Company I, 38th Regiment, 2d Infantry Division, distinguished himself by gallantry in action against an armed enemy of the United Nations, on 24 December 1951, in Korea. As a member of a platoon patrol, Sergeant Gout was moving toward the objective when the patrol was pinned down by a heavy volume of machine gun fire by one of the many enemy outposts along the route of advance. With complete disregard for his own safety, he exposed himself to the enemy gun fire and, using his rifle, killed the entire crew operating the machine gun. After silencing the machine gun, he reorganized his widely dispersed squad. Then, as the patrol moved toward the objective area and became the target of intense automatic weapons and mortar fire, it withdrew. Again Sergeant *Gout* demonstrated indomitable courage and determination by remaining behind to cover the platoon's withdrawal. After assisting wounded men to a safe area, he went forward a second time through heavy automatic weapons fire and provided covering fire for two medics who were pinned down with a wounded man which enabled these men to return safely to the friendly lines. Sergeant *Gout's* heroic conduct, his profound concern for his fellow soldiers, and his gallantry on the battlefield are in the highest traditions of the United States Army and reflect distinct credit upon himself and the military service.

**XII...SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded posthumously to:

Major General *John M. Cone*, , United States Army, distinguished himself by heroism on 30 March 1966 in the vicinity of White Sands Missile Range, White Sands, New Mexico. When his official staff car was flagged down at the scene of an accident on a deserted stretch of road, General *Cone* discovered an overturned automobile with one of the three injured occupants pinned under the vehicle. General *Cone* instructed his driver to attempt to free the trapped man by jacking up the wrecked car. When this effort proved unsuccessful, General *Cone*, with great physical exertion, repeatedly tried to extricate the man from beneath the vehicle until it became evident that the victim could not be removed from the wreckage without further assistance. He then returned to his staff car to call for aid on the car radio and, while reaching for the radio, suffered a fatal heart attack as a result of the extreme effort expended while trying to assist a fellow man. General *Cone's* heroic conduct and profound concern for the welfare of others are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

**XIII...SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Sergeant First Class (then Staff Sergeant) *Vincent P. Boyer*, while serving as a member of Service Battery, 2d Battalion, 83d Artillery, distinguished himself by heroism on 20 August 1965 in Germany. Sergeant *Boyer* was near a refueling station when a tank recovery vehicle, loaded with hundreds of gallons of gasoline, exploded and engulfed the driver in flames. With complete disregard for his own safety, Sergeant *Boyer* swiftly mounted the blazing vehicle and pulled the burned and dazed driver to safety. Continuing to display his indomitable courage and determination, he returned to the burning vehicle and activated the vehicular mounted fire extinguishers, bringing the fire under control. His prompt actions, bravery,

and sound judgment averted further explosions in the fuel storage area and prevented possible injury to personnel on the scene. Sergeant *Boyer's* profound concern for a fellow soldier and heroic conduct in this dangerous situation are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

Master Sergeant *James H. Collier*, as a member of Headquarters and Headquarters Company, 3d Battalion (Airborne), 508th Infantry, Fort Kobbe, Canal Zone, distinguished himself by heroism on 9 July 1965 at the Rio Hato Training Reservation, Republic of Panama. As Safety Noncommissioned Officer on board a C-45 aircraft during a parachute jump exercise, Master Sergeant *Collier* observed that one of the jumpers had a malfunctioning static line and was being dragged behind the aircraft. With complete disregard for his own safety, Master Sergeant *Collier* leaned outside the aircraft in an effort to cut the static line. To accomplish this dangerous feat, he had to lie flat on the floor of the aircraft with the upper half of his body extended outside the door and exposed to the blast of the propellers. Through his determination and courage, he succeeded in cutting the static line which enabled the jumper to fall free, deploy his reserve parachute, and make a safe descent to the ground. Master Sergeant *Collier's* heroic conduct, prompt actions, and profound concern for a fellow soldier are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

First Lieutenant *Francis R. DeCaro, Jr.*, Army Intelligence and Security, United States Army, while serving as a member of Headquarters Troop and S2 of the 1st Reconnaissance Squadron, 3d Armored Cavalry Regiment, distinguished himself by heroism on 30 October 1965 at Grafenwoehr, Germany. Lieutenant *DeCaro* immediately proceeded to a scene of danger when he was informed that an enlisted man was wildly firing an M-14 rifle, had already shot one man, and was threatening others in a troop billet. Displaying an unholstered but unraised pistol at his side, and ignoring the fact that the berserk soldier had previously fired a total of eight rounds, Lieutenant *DeCaro* entered the building and calmly walked into the room where the enlisted man was threatening the men. Then, when he called an order to drop the weapon, the soldier quickly turned around with his loaded rifle, pointed it at Lieutenant *DeCaro*, and stated that he would kill a man if the officer came near him. Despite the threat to his own life and to the lives of the others in the room, Lieutenant *DeCaro* stood fast and repeated his order to drop the weapon. This time, the man obeyed and submitted to custody without a struggle. Throughout the hazardous situation, Lieutenant *DeCaro* demonstrated sound judgment and complete disregard for his own safety in his effort to disarm the distraught soldier and to protect the lives of others. Lieutenant *DeCaro's* determination and heroic conduct in this critical situation are in the highest traditions of the United States Army and reflect great credit upon himself and the military service. (This award supersedes the award of the Army Commendation Medal to Lieutenant *DeCaro* for heroism in Germany on 30 October 1965 as announced in General Orders Number 4, Headquarters, Seventh Army, dated 21 January 1966.)

Lieutenant Colonel *Leland B. Fair*, , Army Intelligence and Security, United States Army, distinguished himself by heroism on 28 and 29 January 1964 while serving as a member of the United States Military Liaison Mission to the Commander in Chief, Group of Soviet Forces in Germany. With complete disregard for his own safety, Colonel *Fair* played a primary role in determining the location of a United States Aircraft that was shot down by Soviet fighters over the Soviet Zone of Germany and the fate of the American crew. His indomitable courage, ingenuity, and decisiveness in demonstrating United States determination to maintain its policy and rights in the Soviet Zone of Germany contributed materially to the security of his country and prevented an international incident. Colonel *Fair's* heroic conduct in this difficult and sensitive situation reflects distinct credit upon himself and the United States Army.

Staff Sergeant *William O. Freyser*, , United States Army, while serving as an Assistant Field Advisor, Special Forces Group (Airborne) with the Republic of Korea Army, distinguished himself by heroism in the vicinity of Seoul, Korea on 3 November 1965. Sergeant *Freyser* was participating in a practice parachute jump when some of the jumpers landed in the deep and dangerous waters of the Han River. As one of the last to leave the aircraft, he managed to land on the bank of the river. Quickly unharnessing himself from his equipment, he disregarded his own safety, plunged into the water, and swam as fast as he could to aid a Korean soldier who was being submerged by the pull of his parachute and heavy combat equipment. Despite the strong current, Sergeant *Freyser* reached the stricken man and pulled him to shallow water in time to prevent a drowning. Sergeant *Freyser's* heroic conduct and profound concern for his fellow man are in the highest traditions of the military service and reflect great credit upon himself and the United States Army.

Captain *Andrew P. Glovas*, , Infantry, United States Army, while serving as Commanding Officer, 15th Psychological Operations Battalion, distinguished himself by heroism at Fort Bragg, North Carolina on 9 January 1966. When a neighbor rushed to Captain *Glovas'* quarters and told him that her house was on fire and that her infant child was trapped in the upper story bedroom, he ran to her home to rescue the baby. Although the dense smoke from the fire on the second floor permeated the stair well, he succeeded in reaching the upper story but was prevented from going into the burning room by the intense heat and smoke. Then, with determination and complete disregard for his own safety, he ignored the danger of asphyxiation, entered the burning area, and located the child. With the infant in his arms, he returned to the head of the stairs where he passed the child to its mother moments before he was overcome by smoke inhalation which required his being assisted from the burning dwelling by others on the scene. Captain *Glovas'* heroic conduct in this hazardous situation and his profound concern for the welfare of the child are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

Specialist Five *Frederick L. Mossop*, , United States Army, Headquarters and Headquarters Company, 1st Battalion (Mechanized), 52d Infantry, 1st Armored Division, Fort Hood, Texas, distinguished

himself by heroism on 18 May 1965 when a pre-dawn flash flood struck San Antonio, Texas. Upon hearing cries for help and learning of the impending disaster to the surrounding neighborhood. Specialist *Mossop* quickly came out of a residence and plunged into the raging waters to assist in the rescue of endangered persons. With complete disregard for his own safety, he participated in the rescue of twenty-four persons, which included several women, many children, and one paralytic invalid. By commiserating with victims and consoling them, he also prevented widespread panic. Specialist *Mossop's* prompt actions, sound judgment, and heroic conduct in this emergency situation are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

Specialist Five *Robert E. Mull*, \_\_\_\_\_, (then Specialist Four), United States Army, while serving as a member of A Battery, 1st Battalion, 13th Artillery, 24th Infantry Division, distinguished himself by heroism on 17 September 1965 in Germany. Specialist *Mull* was driving a truck in the rear of a convoy when he saw an M-109 155mm howitzer suddenly stop. As the crew of the vehicle evacuated it and fled, Specialist *Mull* stopped his truck and ran to the abandoned howitzer to investigate. Upon opening its rear door and looking inside the howitzer which was loaded with explosive projectiles, he saw it ablaze with sparks. A cannister of high explosive powder had shifted and made contact with the vehicle's electrical system. Fully aware of the grave danger, he seized the vehicle's tool bag and disconnected the battery cables. He then dragged the red hot cannister outside. A later inspection of the cannister showed that its packing material had been exposed to intense heat. Through his prompt and courageous actions, Specialist *Mull* prevented possible injury to the personnel in the immediate area and loss of valuable government equipment. His heroic conduct in this emergency situation is in the highest traditions of the United States Army and reflects great credit upon himself and the military service. (This award supersedes the award of the Army Commendation Medal to Specialist *Mull* for heroism on 17 September 1965 as announced in General Orders Number 14, Headquarters, 24th Infantry Division, dated 19 January 1966.)

Master Sergeant *Raymond F. Stoklasa*, \_\_\_\_\_, United States Army, as a member of Headquarters Troop, 1st Squadron, 1st Cavalry, 1st Armored Division, distinguished himself by heroism on 13 October 1965 at Fort Hood, Texas. When a fire broke out in an apartment in a housing area of Fort Hood and commotion ensued, Master Sergeant *Stoklasa* unhesitatingly entered the burning building to determine whether or not anyone was inside. He heard children crying in the upstairs bedroom and, in two attempts to reach them was unsuccessful, once being so overcome by smoke and flames that he had to be dragged from the burning structure by others on the scene. Continuing to demonstrate his determination and complete disregard for his own safety, he then climbed a ladder placed on the outside of the building and was entering the dwelling when the father of the children handed him the youngest child. Master Sergeant *Stoklasa* then carried the one-year-old child down the ladder to safety and the father dropped his three older children into the arms of persons on the ground. Master Sergeant *Stoklasa's* heroic conduct and profound concern

for the welfare of others reflect great credit upon himself and the United States Army.

Specialist Five *Orville R. Thomas*, \_\_\_\_\_, United States Army, as a member of Headquarters Company, Basic Combat Training Committee Group, United States Army Training Center, Fort Leonard Wood, Missouri, distinguished himself by heroism on 9 November 1965 on the Hand Grenade Range of the installation. As Noncommissioned Safety Officer, Specialist *Thomas* was in one of the throwing bays on the live hand grenade course when one of the trainees threw a live grenade in a manner which caused it to strike the front portion of the safety wall and fall into the bay. Instead of following the instruction to remain stationary, the trainee moved in front of Specialist *Thomas* and prevented him from throwing the grenade out of the bay. Specialist *Thomas* grabbed the trainee and pulled him out of the bay fast enough for both of them to hit the ground on the side of the bay just as the grenade exploded. His quick thinking and courageous actions in this dangerous situation averted possible injury or loss of lives. Specialist *Thomas'* heroic conduct is in the highest traditions of the United States Army and reflects great credit upon himself and the military service.

Lieutenant Colonel *Frederick C. Turner*, \_\_\_\_\_, Armor, (then Major), United States Army, distinguished himself by heroism on 9 December 1964, while on a reconnaissance operation for the United States Military Liaison Mission to the Commander in Chief, Group of Soviet Forces in Germany. While in the Soviet engineer bivouac-training area, Colonel *Turner* retained extraordinary coolness and presence of mind, even though in the near proximity of numerous hostile Soviet troops, while performing an act of exceptional courage. He accomplished the operation with consummate skill, without involving the United States in an international incident or jeopardizing the continued existence of his sensitive unit. The exemplary courage and heroism displayed by Colonel *Turner* reflects distinct credit upon himself and the United States Army.

**XIV--BRONZE STAR MEDAL.** By direction of the President, under the provisions of Executive Order 9419, 4 February 1944, a Bronze Star Medal for meritorious service in connection with military operations against an enemy of the United States is awarded to:

**XVI. AIR MEDAL.** By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A 11 September 1942, an Air Medal for heroism while participating in aerial flight is awarded by the Department of the Army to:

Major *Albert J. Soen*, (then Captain), United States Air Force, distinguished himself by heroism while participating in aerial flight on 29 November 1965, approximately forty kilometers northwest of Saigon, Republic of Vietnam. Major *Soen* demonstrated unique flying skill and fortitude while serving as Forward Air Controller and in supporting a ground operation when the 38th Ranger Battalion, Army of the Republic of Vietnam, was forced to withdraw as it came under heavy automatic weapons fire from a well-concealed Viet Cong element. By making low passes over the area, Major *Soen* located the Viet Cong positions. Then, when the strike aircraft arrived, he directed them to the target areas which resulted in the withdrawal of the insurgents. Later that day, as the Viet Cong initiated a two company counterattack and trapped separate units of the Battalion, Major *Soen* again came to the assistance of the friendly forces by repeating his earlier performance of flying low, locating the hostile positions, and directing the strike aircraft to the targets. His indomitable courage, ability as a flyer, and timely support contributed to the success of the Rangers' search and destroy operation which resulted in approximately seventy-five Viet Cong casualties. Major *Soen's* outstanding flying ability and heroic conduct in a combat zone reflect distinct credit upon himself, the United States Air Force, and the armed forces of his country.

Captain *Robert M. Fencer*, , United States Air Force, distinguished himself by heroic achievement on 2 January 1966 while engaged in military operations in the Republic of Vietnam. As Forward Air Controller for the 2d Battalion (Airborne), 503d Infantry, 173d Airborne Brigade (Separate), Captain *Fencer demonstrated* indomitable courage when the Battalion came under intense gun fire by a large force of Viet

Cong insurgents and sustained a number of casualties during the initial burst of hostile gun fire. Although the forward elements of the Battalion were in close proximity to the hostile forces, he immediately moved to a lead position, remained with the forward troops and called in accurate air strikes on the hostile positions. Through his determination and heroic action, the Viet Cong were forced to break contact, leaving behind many of their dead and wounded. Captain *Fencer's* personal bravery and devotion to duty reflect distinct credit upon himself, the United States Air Force, and the armed forces of his country.

Sergeant *Earl F. Morris*, , United States Marine Corps, distinguished himself by heroic achievement on 26 April 1966 while engaged in military operations in the Republic of Vietnam. When a Viet Cong battalion surrounded, attacked, and overran a Vietnamese Commando platoon at Dat Do, Phuoc Tuy Province, Sergeant *Morris* arrived over the hostile area in an Army aircraft as the hostile forces was breaking contact. As the aircraft came into position over the target area, he directed gun fire on the withdrawing Viet Cong, inflicting casualties on them and causing disorganization among the fleeing hostile forces. He then assisted in the acquisition of targets for the strike aircraft which arrived on the scene and, on one occasion marked a target with a smoke hand grenade dropped at tree-top level directly over the Viet Cong positions. During another low pass over the retreating Viet Cong, he fired four magazines from his rifle and struck down one of the insurgents. Through his personal courage and determination, he contributed to the success of a mission which drove off the Viet Cong and relieved the besieged friendly Vietnamese platoon. Sergeant *Morris'* heroic action reflects distinct credit upon himself, the United States Marine Corps, and the armed forces of his country.
