**I. NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE.** DA General Orders 14, 1966, is amended to include the following:

1. *Effective 23 December 1966*, Major General *Raymond L. Murray*, USMC, Assistant Chief of Staff, G3, Headquarters, United States Marine Corps, is appointed to membership on the National Board for the Promotion of Rifle Practice, to serve the unexpired term of Major General *William R. Collins*, USMC.

2. *Effective 23 December 1966*, Brigadier General *William J. Durrenberger*, Commanding General, U.S. Army Weapons Command, is appointed to membership on the National Board for the Promotion of Rifle Practice, vice Major General *Roland B. Anderson*, USA.

3. *Effective 23 December 1966*, Colonel *Jack B. Matthews* (Brigadier General designate), Director of Organization, Unit Training and Readiness Directorate, OACSFOR, is appointed to membership on the National Board for the Promotion of Rifle Practice, to serve the unexpired term of Major General *Arthur L. West, Jr.*, USA.

**II. FORT BUCHANAN, PUERTO RICO.** *Effective 31 December 1966*, Fort Buchanan, Puerto Rico, is placed in an inactive status.

**III. FORT BROOKE, PUERTO RICO.** *Effective 31 December 1966*, Fort Brooke, Puerto Rico (except Rodriguez, U.S. Army Hospital) is placed in an inactive status.

**IV. JUNIOR ROTC UNITS.** 1. *Effective 1 February 1967*, a class IIS Junior ROTC unit is established at Encinal High School, Alameda, California.

2. *Effective on dates indicated*, the class IIS Junior ROTC units established at the following institutions were withdrawn:
