I. RAVENNA ARMY AMMUNITION PLANT, OHIO. *Effective 23 April 1968*, Ravenna Army Ammunition Plant, Ohio, a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is placed in an active status.

II. UNITED STATES ARMY COURIER STATION, CHITOSE. *Effective 15 May 1968*, the United States Army Courier Station, Chitose (AG-W16MAA-00), a subordinate activity of the United States Army Courier Service, is discontinued.

III. SENIOR ROTC UNIT. *Effective 1 March 1968*, the status of the ROTC unit at the University of Texas at Arlington, Arlington, Texas, was changed from a satellite to an independent ROTC unit.

IV. JUNIOR ROTC UNITS. 1. *Effective 26 April 1968*, class HS Junior ROTC units are established at the following institutions under the provisions of AR 145-10:

2. *Effective 1 July 1968*, NDCC units at the following institutions are converted to class HS Junior ROTC units under the provisions of AR 145-10:

- American Military Academy, Guaynabo, Puerto Rico
- San Jacinto Senior High School, Houston, Texas
