I. GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army Support, Thailand, APO San Francisco 96233, is designated by the Secretary of the Army, pursuant to Article 22(a) (6), Uniform Code of Military Justice, to convene general courts-martial *effective 1 August 1968.*

II. GENERAL COURTS-MARTIAL. The Commandant, U.S. Disciplinary Barracks, Fort Leavenworth, Kans. 66027, is designated by the Secretary of the Army, pursuant to Article 22(a) (6), Uniform Code of Military Justice, to convene general courts-martial *effective 1 August 1968.*

4. So much of Section V, DA General Orders 19, 19 April 1967, as pertains to the establishment of a class HS Junior ROTC unit at Egyptian Community High School, Olive Branch, Ill., is rescinded.
