**I. GENERAL COURTS-MARTIAL.** The Commanding General, U.S. Army Field Artillery Center and Fort Sill, Fort Sill, Okla. 73503, is designated by the Secretary of the Army, pursuant to Article 22(a) (6), Uniform Code of Military Justice, to convene general courts-martial, *effective 21 January 1969.*

**II. U.S. ARMY ARTILLERY AND MISSILE SCHOOL.** *Effective 20 January 1969,* the U.S. Army Artillery and Missile School, a class I activity under the jurisdiction of the Commanding General, U.S. Continental Army Command at Fort Sill, Okla., is redesignated the U.S. Army Field Artillery School.

**III. U.S. ARMY ARTILLERY AND MISSILE CENTER.** *Effective 20 January 1969,* the U.S. Army Artillery and Missile Center, a class I activity under the jurisdiction of the Commanding General, Fourth U.S. Army at Fort Sill, Okla., is redesignated the U.S. Army Field Artillery Center.

**IV. MILITARY OCEAN TERMINAL, BAYONNE, N.J.** *Effective 1 July 1968,* Military Ocean Terminal, Bayonne, a class II activity under the jurisdiction of the Commander, Military Traffic Management and Terminal Service, is redesignated a class II installation.

**V. CBR WEAPON SCHOOL, U.S. ARMY DUGWAY PROVING GROUND, UTAH.** So much of section II, General Orders 34, 1962, as reads "CBR Weapon School, U.S. Army Dugway Proving Ground, Utah" is amended to read "U.S. Army CBR Weapons Orientation Course, Dugway Proving Ground, Dugway, Utah."
