**I. GENERAL COURTS-MARTIAL.** The Commanding Officer, Fort Carson and 4th Infantry Division (Mechanized), Fort Carson, Colorado, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial *effective 15 December 1970.*

**II. SENIOR ROTC UNITS. 1.** Senior ROTC units will be established at the following institutions effective for enrollment at the beginning of the academic year 1971-72:

- Alabama A&M College, Normal, Alabama
- Alcorn A&M College, Lorman, Mississippi
- Austin-Peay State University, Clarksville, Tennessee
- Campbell College, Buies Creek, North Carolina
- East Central State College, Ada, Oklahoma
- ~~Grambling College, Grambling, Louisiana~~
- Missouri Western College, St Joseph, Missouri
- Southwestern State College, Weatherford, Oklahoma
- ~~Stout State University, Menomonie, Wisconsin~~
- University of Tampa, Tampa, Florida
- Weber State College, Ogden, Utah
- Wisconsin State University-LaCrosse, LaCrosse, Wisconsin

**2.** *Effective 30 June 1971,* the SENIOR ROTC units at the following institutions will be disestablished:

- Boston College, Boston, Massachusetts
- Pratt Institute, Brooklyn, New York
- Princeton University, Princeton, New Jersey

**3.** *Effective 30 June 1973,* the SENIOR ROTC unit at Stanford University, Stanford, California will be disestablished.

**III. JUNIOR ROTC UNITS. 1.** *Effective 1 September 1970,* a class HS JUNIOR ROTC unit was established at Aliceville High School, Aliceville, Alabama, under the provisions of AR 145-2 with training commencing September 1970.

**2.** *Effective 1 January 1971,* a class HS JUNIOR ROTC unit was established at Ebbert L. Furr High School, Houston, Texas, under the provisions of AR 145-2 with training commencing January 1971.

**3.** *Effective 30 June 1971,* a class HS JUNIOR ROTC unit will be established at Lugoff-Elgin High School, Lugoff, South Carolina, under the provisions of AR 145-2 with training to commence September 1971.

**4.** *Effective 1 September 1970,* class HS JUNIOR ROTC units at the following institutions were disestablished:

- R. J. Kirksey High School, Aliceville, Alabama
- Central High School, Mobile, Alabama
- Mobile County Training School, Plateau, Alabama
- Trinity Gardens High School, Mobile, Alabama
