**I. GENERAL COURTS-MARTIAL.** Confirming verbal order of the Secretary of the Army of 1 April 1971, the Commanding Officer, Eighth United States Army Area Command (Provisional), APO San Francisco 96301, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial.

**II. GENERAL COURTS-MARTIAL.** Confirming verbal order of the Secretary of the Army of 13 April 1971, the Commanding Officer, Third Regional Assistance Command, APO San Francisco 96266, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial *effective 30 April 1971*.

**III. GENERAL COURTS-MARTIAL.** Confirming verbal order of the Secretary of the Army of 15 April 1971, the Commanding Officer, Second Regional Assistance Command, APO San Francisco 96350, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial *effective 30 April 1971*.

**IV. EARTH SCIENCES LABORATORY, U.S. ARMY NATICK, LABORATORIES, MASSACHUSETTS.** *Effective 3 May 1971*, the Earth Sciences Laboratory, including its assigned functions, appropriate personnel, and mission related equipment, is relieved from assignment to the Commanding General, U.S. Army Materiel Command and the U.S. Army Natick Laboratories and assigned to the Chief of Engineers.

**V. JUNIOR ROTC UNITS. 1.** *Effective 1 June 1971*, class HS JUNIOR ROTC units will be established at the following institutions under the provisions of AR 145-2 with training to commence September 1971.

- Hoover High School, San Diego, California
- Haines City Senior High School, Haines City, Florida
- Robert E. Lee High School, Baton Rouge, Louisiana
- Scotlandville Senior High School, Baton Rouge, Louisiana
- Ridgeway Junior-Senior High School, Memphis, Tennessee

**2.** *Effective 1 June 1972*, a class HS JUNIOR ROTC unit will be established at El Capitan High School, Lakeside, California under the provisions of AR 145-2 with training commencing September 1972.

**3.** *Effective 1 July 1971*, class HS JUNIOR ROTC units at the following institutions will be disestablished.

- Helix High School, La Mesa, California
- Clairmont High School, San Diego, California
- Central High School, Jackson, Mississippi
