I. UNITED STATES ARMY INTELLIGENCE SUPPORT AGENCY. Section XXXI, DA General Orders 10, 1974, establishing the United States Army Intelligence Support Agency as a field operating agency under the jurisdiction of the Assistant Chief of Staff for Intelligence is rescinded.

II. UNITED STATES ARMY INTELLIGENCE SUPPORT DETACHMENT. Section XXXII, DA General Orders 10, 1974, transferring the United States Army Intelligence Support Detachment to the United States Army Intelligence Support Agency is rescinded.

III. UNITED STATES ARMY IMAGERY INTERPRETATION CENTER. Section XXXIII, DA General Orders 10, 1974, redesignating and transferring the United States Army Imagery Interpretation Center to the United States Army Intelligence Support Agency is rescinded.

IV. UNITED STATES ARMY SPECIAL RESEARCH DETACHMENT. Section XXXIV, DA General Orders 10, 1974, transferring the United States Army Special Research Detachment to the United States Army Intelligence Support Agency is rescinded.

V. UNITED STATES ARMY INTELLIGENCE THREAT ANALYSIS DETACHMENT. Section XXXV, DA General Orders 10, 1974, transferring the United States Army Intelligence Threat Analysis Detachment to the United States Army Intelligence Support Agency is rescinded.

VI. GENERAL COURTS-MARTIAL. Effective 23 August 1974 the following organization/unit is attached, as indicated, for the exercise of general court-martial jurisdiction and the general administration of military justice, excluding Article 15, UCMJ, jurisdiction, and including related administrative actions as requested by the attached organization/unit. VII. DEPARTMENT OF THE ARMY MILITARY REVIEW BOARDS AGENCY. *Effective 1 July 1974*, the Department of the Army Military Review Boards Agency is established as a field operating agency under the jurisdiction of the Office, Secretary of the Army. Effective the same date, the Army Council of Review Boards and the Army Board for Correction of Military Records are discontinued and their personnel, records and functions transferred to the Department of the Army Military Review Boards Agency.

VIII. JUNIOR ROTC UNIT. *Effective 15 August 1974*, the Junior ROTC unit at Wooster High School, Wooster, Ohio, will be disestablished.

IX. JUNIOR ROTC UNIT. *Effective 19 August 1974*, the name of George W. Brackenridge High School, San Antonio, Texas, was changed to Phillis Wheatley High School.
