I. GENERAL COURTS-MARTIAL. The Commander, Military Traffic Management Command, Eastern Area, Bayonne, New Jersey 07002, is designated by the Secretary of the Army pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial effective 23 May 1977.

II. UNITED STATES ARMY COMPUTER SYSTEMS SUPPORT AND EVALUATION AGENCY (SFW2Y2AA)—REDESIGNATED. Effective 20 May 1977, the United States Army Computer Systems Support and Evaluation Agency, a staff support agency under the jurisdiction of the Army Automation Directorate, OCSA, is redesignated the United States Army Computer Systems Selection and Acquisition Agency.

III. SENIOR ROTC UNITS. Effective 30 June 1977, the following Senior ROTC units will be disestablished:

- University of Alaska, Fairbanks, Alaska.
- University of Connecticut—Waterbury Branch (Satellite Unit) Waterbury, Connecticut.
- DePaul University, Chicago, Illinois.
- Potomac State College, Keyser, West Virginia (Satellite Unit).

IV. JUNIOR ROTC UNITS. Effective 1 July 1977, the following Junior ROTC units will be established:

- Dixie Hollins High School, St. Petersburg, Florida.
- George Washington High School, Los Angeles, California.
- Murrah High School, Jackson, Mississippi.
- Vicksburg High School, Vicksburg, Mississippi.
- Wingfield High School, Jackson, Mississippi.
- Youngstown Public School, Youngstown, Ohio.
