**I. DISTINGUISHED FLYING CROSS.** By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Distinguished Flying Cross for extraordinary heroism while participating in aerial flight is awarded by the Department of the Army to:

Major *Frank L. Alverson, Jr.*, (then First Lieutenant), Air Defense Artillery, United States Army, for heroism on 3 October 1965, while a member of 197th Attack Helicopter Company, Republic of Vietnam. This award is authorized under provisions of paragraph 1-13, AR 672-5-1.

**II. SILVER STAR.** By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Major *James L. Cadigan*, (then Second Lieutenant, Infantry) United States Army, for action on 26 February 1945, while a member of Company C, 20th Armored Infantry Battalion, 10th Armored Division. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1. (Under the provisions of para 1-17, AR 672-5-1, this award supersedes the award of the Bronze Star Medal with "V" Device for heroic achievement on the same day).

First Sergeant *Stephen R. Kuykendall*, United States Army, for action on 18 March 1968, while a member of Company D, 3d Battalion, 187th Infantry, 101st Airborne Division. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

**III. LEGION OF MERIT.** By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Major General *Horst-Bodo Schawwirth*, Army of the Federal Republic of Germany, 1 August 1975 to 31 July 1976.

Major General *Choi Suk Shin*, Republic of Korea Army, January 1974 to August 1975.

MG *Kang Yeung Sik*, Republic of Korea Army, 20 August 1975 to 15 October 1976.

**IV--SOLDIER'S MEDAL. 1.** By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Sergeant *George E. Alsobrooks*, , United States Army, for heroism on 10 August 1976, while a member of Company B, 385th Military Police Battalion.

Specialist Four *Brian L. Alley*, , United States Army, for heroism on 26 November 1975, while a member of the 1st Battalion (Airborne), 505th Infantry, 82d Airborne Division.

Specialist Five *David D. Britt*, , United States Army, for heroism on 14 December 1974, while a member of the United States Army Support Command, Hawaii. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Specialist Four *Alpido G. Correa*, , United States Army, for heroism on 25 July 1976, while a member of the 587th Signal Company, 52d Signal Battalion.

Staff Sergeant *John E. Dimsdale*, , United States Army, for heroism on 6 June 1976, while a member of 2d Replacement Detachment, 2d Infantry Division.

Captain *Larry A. Gleason*, , Military Police Corps, United States Army, for heroism on 17 January 1977, while a member of the 546th Military Police Company.

Captain *James T. Jackson*, , (then First Lieutenant) Infantry, United States Army, for heroism on 16 March 1975, while a member of Headquarters and Headquarters Company, 2d Battalion (Ranger), 75th Infantry.

Sergeant *Robert R. Luna*, , United States Army, for heroism on 27 August 1976, while a member of 2d Battalion, 50th Infantry, 2d Armored Division.

Specialist Four *Robert G. Malton*, , United States Army, for heroism on 14 September 1976, while a member of Battery D, 1st Battalion (Airborne) 509th Infantry, 8th Infantry Division.

Specialist Four *Glen D. Mahunao*, , United States Army, for heroism on 17 September 1976, while a member of Company B, 3d Battalion, 6th Infantry, Berlin Brigade.

Sergeant First Class *Stanley R. Miller*, , United States Army, for heroism on 2 July 1976, while a member of the 130th Station Hospital.

Sergeant First Class *William D. Moreland*, , United States Army, for heroism on 21 August 1976, while a member of Headquarters and Headquarters Company, 2d Armored Division.

Sergeant First Class *Wendell E. O'Brien*, , United States Army, for heroism on 21 August 1975, while a member of Company C, 2d Battalion, 7th Special Forces Group (Airborne).

Sergeant *Levy E. Pate*, , United States Army, for heroism on 21 August 1976, while a member of 2d Battalion, 50th Inf, 2d Armored Division.

Specialist Four *Dwight A. Rowland*, , United States Army, while a member of Company A (Airborne), 3d Battalion, 5th Infantry, Fort Kobbe, Canal Zone.

Specialist Five *Donald R. Smith*, , United States Army, for heroism on 10 July 1976, while a member of the 2d Battalion, 50th Infantry, 2d Armored Division.

First Lieutenant *William H. Stith*, , Medical Service Corps, United States Army, for heroism on 21 August 1976, while a member of Headquarters and Headquarters Company, 2d Battalion, 50th Infantry, 2d Armored Division.

Staff Sergeant *Regie A. White*, , United States Army, for heroism on 19 August 1976, while a member of the 45th Field Hospital.

Specialist Five *William A. Williams, III*, , United States Army, for heroism on 19 August 1976, while a member of the 45th Field Hospital.

2. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, A Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Private First Class *Ham Kwang Hyun*, , A Korean Augmentation to the United States Army, for heroism on 12 August 1975, while assigned to Battery A, 1st Battalion, 44th Air Defense Artillery.

**V. BRONZE STAR MEDAL.** 1. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" Device for heroism in connection with military operations against hostile forces is awarded to:

Captain *Floyd J. Davis*, , (then second Lieutenant) Military Police, United States Army, for action on 17 March 1968, while a member of the Headquarters and Headquarters Detachment, Security/Long Range Reconnaissance Platoon, 3d Brigade, 101st Airborne Division. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Chief Warrant Officer *Lester A. Hansen*, , United States Army, for heroism on 13 August 1969, while a member of 170th Aviation Company, 17th Aviation Group, 1st Aviation Brigade. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Staff Sergeant *Maurich H. Moore*, , United States Army, for heroism on 12 May 1968, while a member of Company E, 2d Battalion, 1st Infantry, Americal Division, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Captain *Robert B. Sauve*, , Infantry, United States Army, for heroism on 1 May 1972, while serving as Deputy Senior Advisor, 4th Ranger Group, Army of the Republic of Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Private First Class *Roger L. Wamsley*, , United States Army, for heroism on 12 June 1971, while a member of the 560th Military Police

Company, 93d Military Police Battalion, 16th Military Police Group, 18th Military Police Brigade. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

2. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal (First Oak Leaf Cluster) with "V" Device for heroism in connection with military operations against hostile forces is awarded to:

Sergeant First Class *Donnie L. Paul*, (then Captain) United States Army, for heroism on 28 April 1970, while a member of Company A, 173d Support Battalion, 173d Airborne Brigade. This award is authorized under provisions of paragraph 1-13, AR 672-5-1.

Private First Class *Ronald G. Tompkins*, United States Army, for heroism on 12 June 1971, while serving with the 560th Military Police Company, 93d Military Police Battalion, 16th Military Police Group, 18th Military Police Brigade. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

**VI...ARMY COMMENDATION MEDAL.** By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal for meritorious service is awarded to:

Captain *Thomas Blum*, Army of the Federal Republic of Germany, 11 Dec 1972 to 14 May 1976.

Lieutenant Colonel *Gerhard U. Dobbert*, Army of the Federal Republic of Germany, 1 Jul 1972 to 28 Nov 1976.

Captain *Miguel A. Daza Pinzon*, Colombian Army, 21 April 1975 to 31 January 1977.

Lieutenant Colonel *Rodolfo J. Rodriguez*, Army of Argentina, 16 December 1974 to 16 December 1976.

Master Sergeant *Ananda Singaboon*, Royal Thai Army, 2 January 1960 to 1 March 1977.

First Lieutenant *Manfred M. Wagner*, PK Army of the Federal Republic of Germany, 1 March 1974 to 25 June 1976.

**VII...DISTINGUISHED FLYING CROSS.** So much of Section IV, General Orders Number 51, 1974, Headquarters, Department of the Army, as pertains to award of the Distinguished Flying Cross to Captain *William S. Reeder, Jr.*, Field Artillery, United States Army, as reads: "Distinguished Flying Cross" is amended to read: "Distinguished Flying Cross (First Oak Leaf Cluster)."

**VIII...SILVER STAR.** So much of Department of the Army General Orders Number 85, 1969, Headquarters, Department of the Army, as pertains to the award of the Silver Star (First Oak Leaf Cluster) to Major *Otis H. Ashley, III*, (then First Lieutenant) Infantry, United States Army, for gallantry in action on 16 June 1966, is revoked.

**IX...SOLDIER'S MEDAL.** So much of Section VII, General Orders Number 23, 1976, Headquarters, Department of the Army, as pertains to the award of

the Soldier's Medal to Specialist Four *Martin D. McGinnis*, United States Army, as reads: "1st Battalion, 19th Infantry, 25th Infantry Division" is amended to read: "1st Battalion, 5th Infantry, 25th Infantry Division."

**X. ARMY COMMENDATION MEDAL.** So much of Section XVI, General Orders Number 15, 1968, Headquarters, Department of the Army, as pertains to award of the Army Commendation Medal to Colonel *Russell C. Roberts, Jr.*, FR46185, (then Major) United States Air Force, as reads: "Army Commendation Medal" is amended to read: "Army Commendation Medal (First Oak Leaf Cluster)."

**XI. UNITS ENTITLED TO BATTLE CREDITS.** 1. So much of War Department General Orders Number 116, 1945, is amended to delete "147th Army Postal Unit." 2. So much of War Department General Orders Number 118, 1945 is amended to add "147th Army Postal Unit."
