**I. GENERAL COURTS-MARTIAL.** Effective 12 December 1978 the following organization/unit is attached, as indicated, for the exercise of general court-martial jurisdiction and the general administration of military justice, including the exercise of inferior court-martial jurisdiction and related administrative actions.

**II. ASSISTANT SECRETARY OF THE ARMY (IL&FM).** Effective 24 December 1978, the Assistant Secretary of the Army (IL&FM) is designated the Army Safety and Occupational Health Official.

**III. ARMY STAFF SAFETY FUNCTION.** Effective 24 December 1978, the Army Staff safety function is transferred from The Inspector General to the Deputy Chief of Staff for Personnel.

**IV. UNITED STATES ARMY AGENCY FOR AVIATION SAFETY.** Effective 24 December 1978, the United States Army Agency for Aviation Safety, a field operating agency under the jurisdiction of The Inspector General, is transferred, as a field operating agency under the jurisdiction of the Deputy Chief of Staff for Personnel, and redesignated the United States Army Safety Center.

**V. JUNIOR ROTC UNIT.** Effective 30 June 1979, the Junior ROTC unit at Wilbur D. Mills High School, Little Rock, Arkansas will be disestablished.
