I. SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:

Sergeant First Class *Lawrence J. Englander*, (then Sergeant), United States Army, for heroism on 2 May 1968, while a member of Company C, 5th Special Forces Group. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

II. SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Major *William M. Byrd*, (then First Lieutenant), Infantry, United States Army, for heroism on 23 and 24 April 1944 in Dutch New Guinea. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1. (This award supersedes the award of the Bronze Star Medal with "V" Device as announced in General Orders Number 27, 1947, Headquarters, Department of the Army, Washington, DC.)

Private First Class *Harry A. Swan*, United States Army, for heroism on 5 February 1945, while a member of Company G, 3d Battalion, 511th Parachute Infantry Regiment, 11th Airborne Division, Philippine Islands. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

III. LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Lieutenant General *Agamemnon Gratzios*, Army of Greece, August 1977 to February 1979.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion

IV. DISTINGUISHED FLYING CROSS. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, the Distinguished Flying Cross for heroism while participating in aerial flight is awarded posthumously to :

Major *Lawrence R. Booth*, , (then Captain), Field Artillery, United States Army, for action on 13 October 1969, while a member of 131st Aviation Company, 212th Aviation Battalion, 16th Aviation Group, 1st Aviation Brigade, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Sergeant *Dennis D. Morris*, , United States Army, for heroism on 8 July 1978, while assigned to the 891st Engineer Company.

Specialist Four *Daniel Sampsel*, , United States Army, for heroism on 21 July 1978, while a member of Company C, 3d Medical Battalion.

Chief Warrant Officer *Michael Z. Smith*, , United States Army, for heroism on 5 October 1978, while assigned to Service Battery, 2d Battalion, 5th Field Artillery.

Specialist Four *Jeffery A. Stern*, , United States Army, for heroism on 17 August 1978, while a member of Company C, 3d Battalion, 33d Armor, 3d Armored Division.

Chief Warrant Officer *Talamon L. Weaver*, , United States Army, for heroism on 20 September 1978, while a member of Air Troop, 11th Armored Cavalry Regiment.

Chief Warrant Officer *Donald L. Welchance*, , United States Army, for heroism on 20 September 1978, while a member of Air Troop, 11th Armored Cavalry Regiment.

VII. AIR MEDAL. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal with "V" Device for heroism while participating in aerial flight is awarded posthumously by the Department of the Army to:

Staff Sergeant *Kenneth L. Cunningham*, , (then Specialist Five), United States Army, for heroism on 3 October 1969, while a member of the 225th Aviation Company, 223d Aviation Battalion, 17th Aviation Group, 1st Aviation Brigade, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

VIII. AIR MEDAL. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal (eighteenth Award) with "V" Device for heroism while participating in aerial flight is awarded by the Department of the Army to:
