**I—ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 13TH FIELD ARTILLERY REGIMENT UNDER THE US ARMY REGIMENTAL SYSTEM (USARS).**

1. The 13th Field Artillery regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 16 March 1987.
2. HHB, 1st Bn, 13th Field Artillery, UIC: WAQBAA will be REORGANIZED and REDESIGNATED as Btry A, 13th Field Artillery, UIC: WAQBAA under MTOE 6-398JFC24, FC1087 with the following strengths: STSTR: 6 OFF, 125 ENL, 131 AGG-AUSTR: 6 OFF, 125 ENL, 131 AGG and remains ASSIGNED to the 24th Infantry Division at Fort Stewart, GA, effective 16 March 1987.
3. The remaining organic batteries of the 1st Bn, 13th Field Artillery will be INACTIVATED effective 16 March 1987.

**II—ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 506TH INFANTRY REGIMENT UNDER THE US ARMY REGIMENTAL SYSTEM (USARS).**

1. The 506th Infantry regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the US Army Regimental System, effective 16 March 1987.
2. The 1st Bn, 9th Infantry, UIC: WAJJAA will be INACTIVATED in Korea under MTOE 7-15HP801, P80187, effective 16 March 1987. The 1st Bn, 506th Infantry, UIC: WAJJAA will be ACTIVATED and ASSIGNED to the 2d Infantry Division in Korea under MTOE 7-15HP801, P80187 with the following strengths: STSTR: 40 OFF, 2 WO, 757 ENL, 799 AGG-AUSTR: 40 OFF, 2 WO, 684 ENL, 726 AGG, effective 16 March 1987.
